8. TfL Update including Low Emission Zone

Ivan Thomas raised the issue about changes to the Low Emission Zone affecting central London from April 2019 and the whole of London from October 2020, subject to the outcome of consultation. He was specifically concerned about the lack of suitable retrofit equipment and the prospect that solutions will not be in place in time. He also asked whether subsidies would be available to assist with retrofitting and / or whether retrofit vehicles would command a reduction in road tax as it had in a previous scheme.

Andy Palmer said that many of these issues would be tackled at the Panel Discussion in September. However, in the meantime, **Peter Bradley** said that he would approach Daniel Hayes of the Low Carbon Vehicle Partnership to see what assistance they may be able to offer.
